Compliance Success at the Human Genome Sequencing Center at Baylor College of Medicine

As a NIH grant holder, BCM-HGSC is required to comply with FISMA guidelines, including NIST 800-37 and NIST 800-137. BCM-HGSC needed to demonstrate initial compliance on a tight timeline and to quickly onboard deep expertise and process experience. BCM-HGSC

also wanted to implement a risk management program to support the security authorization & assessment process, maintain their ATOs and sustain NIH funding.

BCM-HGSC called on TalaTek to help with their immediate requirement
